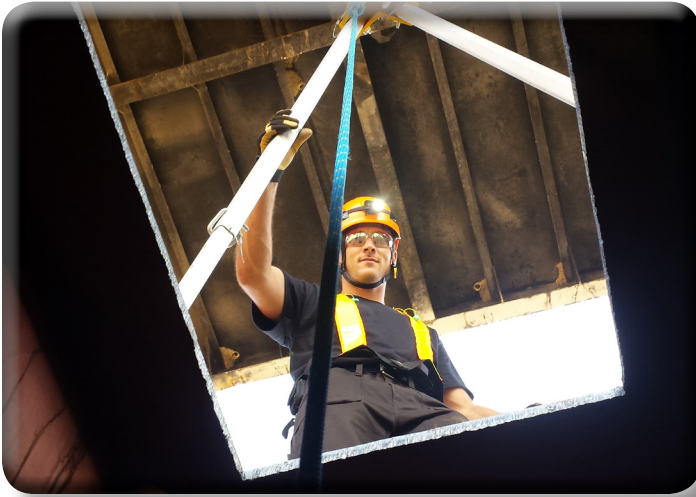




# Confined Space Entry Mining Industry

The Mines Act and the accompanying Health, Safety and Reclamation Code for mines in BC protect workers health and safety and references legislation related to confined space activities.

This Confined Space Entry course will establish an understanding of the statutory requirements of the federal COHS, Provincial and Territorial OH&S legislations, Mines Act and the accompanying Health, Safety and Reclamation Code for mines in British Columbia.

We will achieve this through discussion of confined space fundamentals and by participating in skills exercises.

By the end of this Confined Space Entry course you will be able to:

- ▶ Describe a Confined Space.
- ▶ Describe various hazards and know how to handle hazards that are identified.
- ▶ You will understand the information every employee needs to know in order to avoid accidental exposure.
- ▶ The Mine Act requires that a written operating procedure for confined space entry be implemented.
- ▶ Should something go terribly wrong, you will know how to effect a non-entry rescue.
